<input type="checkbox"/> <b>Support Firefighter</b> -Must be at least 18 years old. -This position requires ability to safely provide various exterior support tasks at fires and other emergencies. -Must have ability to complete training tailored to your level of participation or have previous firefighting experience.
<input type="checkbox"/> <b>Administrative Member</b> -Must be at least 18 years old -This is a non-emergency position that provides various administrative tasks pertaining to the business operations of the company
<input type="checkbox"/> <b>Junior Member</b> -Must be between the ages of 14 and 17 -This position allows minors to learn about firefighting and/or the fire company in controlled environment. -Applicants for junior membership and their parents or guardians must meet with designated company officials prior to acceptance.
